4 Ravensbourne Students' Union End of Year Report

SUA briefly scrutinised the activities undertaken by the Union in the past year. Although, the Union was not able to deliver everything that was planned because of the lack of capacity, the Board was largely happy with the Union's accomplishments. The Board members advised the officers to learn from the experience of the past year, be practical about what the team can achieve and decide their priorities according to their resources. The following were also advised to the team:

- Use several social media platform to engage with the community
- Promote the benefit of having an NUS card

The Union budget was underspent by about £13K. The Union officers were advised to be more practical about planning their budget for the next academic year.

It was also noted that the Union, as all other departments of the University, were waiting for their budget.

The SU President briefly detailed the activities undertaken by the Union in the past couple of months. It was noted that no physical events were possible because of safety reasons. The SU President highlighted the importance of holding both virtual and physical event where possible.

It was advised that the Union should plan all future activities with a time and date and advertise those well.

The SU Manager noted that the consultation process of the SU strategy has now completed. The draft strategy will be submitted to the next Board meeting for approval.

The Board members noted the following:

- The SU should not become a fully independent entity in the new near future
- The SU should operate as a department of the University
- The University may consider providing a fixed amount of yearly budget to the SU
- The structure of the SU should be reviewed
- Improving the NSS score for both the University and the SU to be incorporated in the SU strategy
